LTLT's program work is organized around the three areas of conserve, restore, and connect.

Conserve: In 2015, LTLT made two land purchases and exchanged property for a total of 236 acres for future public access, conveyed 1.2 acres with two historic structures to Preservation North Carolina to be sold for preservation, and closed three conservation easements protecting 108 acres in two of its seven-county project area. Conservation values included 44,143 feet of stream frontage, 7.61 acres of wetlands, 5390 feet of U. S. Forest Service boundary and 3959 feet of North Carolina Game Lands boundary. LTLT also conducted onsite monitoring of 66 conservation easements.

Restore: In partnership with landowners, other nonprofits, and government agencies LTLT helped to restore approximately 2,500 linear feet on 3 streams in our service area. Additionally, LTLT planted 530 trees & shrubs in a natural area of its "Welch Farm" property.

Connect: Through 89 educational events, LTLT's citizen science/education program reached 3942 people, 76% of whom were youth. Through many partnerships, LTLT's youth educational programs spread to all seven counties in LTLT's service area. LTLT completed the 27th year of collecting aquatic biomonitoring data in the Little Tennessee River watershed to observe trends in stream health. LTLT also collaborated with 25 partner agencies/organizations on 6 significant area projects.
