In 2016, Mainspring continued achieving its conservation mission by conserving land, restoring water quality, and connecting people to natural and cultural resources.

Through its numerous 2016 projects, Mainspring conserved 21 headwater springs, 344 acres, 2.4 miles of mountain streams, 8,843 feet of public land boundary, and opened 767 acres for public access. Specifically, it provided services to one family who conserved 202 acres of mountain land with significant headwaters in the Tuckaseegee River Watershed. Mainspring completed one 308-acre land purchase and subsequently enrolled it in the North Carolina Game Lands program. And, following the completion of eight discrete land transactions over multiple years, Mainspring donated 427 acres to the United States Forest

Service to help form a protected wildlife corridor between the Cowee and Nantahala Mountain Ranges and connect three "outlying" parcels of Nantahala National Forest land to the greater public land holdings, making all of those lands accessible for public recreation and enjoyment. Mainspring's stewardship staff walked 170 miles conducting onsite monitoring of 54 conservation easements held by Mainspring to ensure the conservation values remained intact.

Mainspring partnered with landowners and government agencies on two major stream restorations and continued its "clean-up" efforts on a brownfield site lying along the Little Tennessee River in Franklin, NC, including planting 32 trees on the site. Through

Mainspring's "Shade Your Stream" program, it partnered with the Town of Franklin to restore Crawford Branch in its Memorial Park.

Through numerous educational events, Mainspring reached 2,156 youth, helping children understand the importance of the area's natural resources. Also, staff and volunteers completed the 28th year of collecting aquatic biomonitoring data in the Little Tennessee River watershed to observe trends in stream health and give volunteers an "up close" look at aquatic biodiversity.

All officers and employees complete a conflict of interest statement at the first board meeting of the new year and the statement is reviewed by the Finance Manager. In addition, the ED monitors the business of the organization that could involve Board members or staff.

Pt VI, Line 12c In the annual budgeting process, the Board approves a budget line for aggregate salary expense. Thereafter, individual salaries and salary increases for employees are determined by the Executive Director using comparable salary information for land trust nonprofit organizations with similar budgets. The Compensation Committee sets the Executive Director salary after a performance review and a check of comparable salary information for related land trust nonprofit organizations with similar budgets. Currently the ED makes well below the highly compensated threshold for other land trust nonprofits.

During the 2016 Form 990 preparation, it was discovered that the public support test on the 2015 Form 990, encompassing the five years 2011-2015, 3 donors had their donations classified as private support when these donors were actually publically supported organizations whose donations should have been reflected in public support. The 2016 Form 990 includes the restatement of all effected amounts. The effect of the correction was to increase the cumulative public support percentage. The change was not related to a tipping point issue, as the organization's public support has been above 50% throughout its history.
